APPLICATION for TEACHER ASSESSMENT

Chiron Healing® Teacher Assessments may be undertaken by any person who has completed the required units of study.

All applications for Chiron Healing® Teacher assessments must be made on this form and the correct application fee must be included. Failure to comply with the correct procedure may result in delays with your assessment application.

- All Chiron Healing® Teacher assessments must be conducted by an IACHI Teacher Assessor qualified at the correct level.
- All Teacher Assessors must be approved by AESC.
- Applicants may request that their assessment be conducted by a Teacher Assessor of their choice by mutual agreement, otherwise AESC will appoint a Teacher Assessor for you.
- Applicants who conduct an assessment workshop in a language other than that spoken by the Assessor may need to provide a translator for the Assessor. Specific guidelines are given in the IACHI Teacher's Handbook.
- All forms and documentation may be obtained from your Teacher Mentor, from your Assessor, from AESC (contact details below), or downloaded from the Chiron Healing® website at www.iachi.com.au

PROCEDURE to APPLY for ASSESSMENT:

1. Complete all sections of this application form and return to AESC at the address given below. Please make sure to include the correct **assessment fee** and copies of your **Certificate(s) of Competency** for your supervised Teacher training.
2. Upon receipt of your application, your assessment fee will be forwarded to IACHI and a receipt will be issued to you.
3. Your application will then be processed by AESC, and your Teacher Assessor will be approved or appointed.
4. You will be contacted by your Teacher Assessor to set a date for the assessment seminar, and to complete all other preliminary requirements, as set out in the IACHI Teacher's Handbook.
5. Following your assessment you will receive written notification of the outcome:
 - a) Successful Assessment – a **“Certificate of Competency”** will be issued and given to you.
 - b) Unsuccessful Assessment – the Assessor will notify you of the area(s) where improvement is required. You may arrange a time with your Assessor to discuss those areas.

N.B. Following successful assessment, **applicants must then apply for official accreditation** to register as an IACHI Teacher. Please use the **“Application for Teacher Accreditation”** form (available to download from www.iachi.com under the AESC tab > Forms). There is no fee for Teacher accreditation.

Once approved, the Teacher is admitted as an IACHI Teacher member at the new level and their Teacher Certificate is issued.
